This procurement process is governed by Procurement Guidelines under Loans Extended by the OPEC Fund for International Development (OFID), (November 1982), approved by the OPEC Fund for International Development (OFID)

- 1. The Employer now invites sealed tenders from Contractors for the following contract SoW to be funded from part of the proceeds of the loan:
 - Furnishing the following stations with the new interlocking devices: Blazuj, Hazici, and at the stations Rastelica, Pazaric and partly Sarajevo it is necessary to perform reconstruction of the existing signalling equipment.
 - On the line section Blazuj -Bradina it is also necessary to install system of interstation dependence in accordance with existing design documentation.
 - Point heating on the line section Sarajevo-Bradina. The design documentation only includes power supply to the point heating and other components as described in BoQ. The Contractor has the duty to complete the existing Design for the power supply to the point heating and include the same with annex to the project made by ZFBH.
 - Power Substation in Raštelica and Power Substation in Hadzici, both of them shall be rehabilitated and put into operation in accordance with Normative in force and as per Technical Specification.
 - Electric substation Blazuj to be rehabilitated in accordance with Tender Documentation

It is estimated that the construction Contract for this project shall last for the period of 12 months plus 12 months of DNP.

2. To be qualified for the award of a contract, tenderers must satisfy the following minimum criteria including those inserted in the tables attached to the tender document:

Financial Situation

The audited balance sheets for the last five (5) years (i.e 2009, 2010, 2011, 2012 and 2013) shall be submitted and must demonstrate the soundness of the Tenderer's financial position, showing long-term profitability. Where necessary, the Employer will make inquiries with the Tenderer's bankers.

The Tenderer shall have an average annual turnover as prime contractor (defined as billing for works in progress and completed) over the last 5 years (i.e.2009, 2010, 2011, 2012 and 2013) of not less than 10 mill EURO. The Tenderer shall demonstrate that it has access to, or has available, liquid assets, unencumbered real assets, lines of credit, and other financial means sufficient to meet the construction cash flow for the contract for a period of 6 (six) months, estimated as not less than 4 mill EURO.

Experience

The Tenderer, in the capacity of prime contractor, must have successfully completed (the Taking-Over Certificate has been issued) at least 2 contracts (each project of minimum EUR 10 million value) of a nature and complexity comparable to the proposed contract (*Railway Signalling and Telecommunication works*) over the last 5 years 2009, 2010, 2011, 2012 and 2013.
